# **Privacy Policy**

# **General Issues**

The Managers Latvian GIS Association, that processes people's data, follow General data protection regulations Nr.2016/679 (General data protection regula) requirements, along with other regulatory requirements/enactments in Latvia.

This privacy policy explains, how Latvian GIS Association processes personal data, procedure for acquiring and keeping the subject's data, and questions about personal data protection. Latvian GIS Association's privacy policy pertains to all data processing that Latvian GIS Association does.

### Personal data processing goals and legal basis

Latvian GIS association personal data processing goals are associated with Latvian GIS association's functions. Latvian GIS association processes personal data with these goals:

• Participants register for Latvian GIS association's hosted events

Latvian GIS association processes personal data with the legal basis:

• Data subject's consent

During Latvian GIS association's organized events, pictures and videos may also be taken for public information purposes.

Personal data storage agreement

Latvian GIS association stores personal data according to the defined personal data processing goals and requirements of regulations, while they meet these criteria:

• By registering to the Latvia's GIS Association event, you agree that your personal data will be collected and further processed by the Latvia's GIS Association to send you information about current and upcoming events. The data will not be used for any other purpose.

#### Personal data receivers

Personal data is not given to any third parties

### Access to your personal data and other rights of the data subjects

To access your personal data, which Latvian GIS association is processing, the data subject needs to fill out and application document;

- Personally, written by hand and turned in at Latvian GIS association's office, Krasta street 105a, Riga, Latvia, showing personal documents proving your identity
- Or by email and electronic signature, it can safely be sent to <u>info@latgis.eu</u>

Data subjects have a right to ask for personal data processing limitations, object to personal data processing, erasing of personal data or ask that personal data be fixed to regulation standards.

Latvian GIS association maintains communication with the data subject, utilizing the data subjects contact information (e-mail, telephone number, address)

If the data subjects deem their data subject rights about their personal data have been violated, the subject can then legally send in a complaint to the data supervisors.

## *Rights to revoke agreement*

If the processing of personal data has been initiated and is in accordance with the data subject's consent, the data subject has the right to revoke their agreement, by personally handing in a signed letter to Latvian GIS association main office Krasta street 105a, Riga, Latvia, providing their correct documentation or by sending in the form via secured electronic signature to info@latgis.eu.

The revocation of consent does not affect data processing, which at the time was allowed with consent of the owner.

The withdrawal of consent, while processing, will be performed on the basis of other legal grounds.
